General Information & Conditions

Reservations:

A deposit of \$500.00 per person is required to confirm your reservation. The balance is due 60 days prior to departure.

Rates:

Prices are per person, based upon two persons sharing accommodations with private bath. Members occupying single rooms, either by choice or circumstances, will pay the single room supplement.

Transfers of passengers and luggage will be provided throughout the tour.

Sightseeing, as shown in the itinerary, will be by motorcoach, minibus, private car, jeep, boat or other conveyance.

Cancellation & Refunds:

Cancellations must be received in writing and are subject to the following penalties:

- Up to 60 days prior to departure: \$200 per person
- 30 - 60 days prior to departure: \$500 per person
- 15 - 30 days prior to departure: \$1,000 per person
- Less than 15 days prior to departure: No Refund

In addition to the above land charges, there may be charges made by the airlines. No partial refund or credit will be given for unused services.

Trip Cancellation Insurance:

To protect yourself against cancellation fees, should you be unable to travel for certain reasons, we highly recommend trip cancellation insurance. A form will be sent to you for your convenience.

Not Included:

Passport or visa fees, airport taxes, excess baggage charges, meals not shown, laundry, liquor, mineral waters and expenses of a personal nature.
